**CALLED COUNCIL MEETING**

The Called Meeting of the Mayor and Council of the City of Cleveland was called to order by Mayor Pro Tem Bradley Greene at 6:00 p.m.

**COUNCIL MEMBERS PRESENT:** Nan Bowen, Annie Sutton, Kevin Stanley, and Bradley Greene. Mayor Ash arrived and proceeded over the meeting.

**APPROVAL OF AGENDA**

On motion by Bradley Greene, seconded by Kevin Stanley, in favor – Nan Bowen and Annie Sutton, and carried unanimously, the Mayor and Council voted to approve the agenda for the Called Council Meeting for the second public hearing of the 2019 Millage Rate and Tax Digest.

**2019 MILLAGE RATE AND TAX DIGEST – PUBLIC HEARING AND DISCUSSION – 2<sup>nd</sup> CONSIDERATION**

Mayor Ash opened the floor for public discussion. There was no one present from the public to discuss the millage rate or tax digest.

Mayor Ash held the meeting open for ten minutes in the case someone from the public would attend the meeting. During this time, there was no discussion other than Grant Keene, City Attorney, inquiring on the city's oldest piece of equipment. Fire Chief Ricky Pruitt answered it would be the 1956 Ford Fire Truck.

After the time elapsed, Mayor Ash again stated for the record he was opposed of going up on the millage from 5.899 to 6.00. The City Council was not asked to make comment.

On motion by Kevin Stanley, seconded by Bradley Greene, in favor – Nan Bowen and Annie Sutton and carried unanimously, the City Council voted to accept the second consideration of the 2019 Millage Rate and Tax Digest from 5.899 to 6.00.

The third public hearing and adoption will be held Thursday, July 25, 2019 at 9:00 a.m.

**ADJOURNMENT**






